Nevada Ready! is United Way's grant-funded initiative to support the improvement and expansion of pre-kindergarten spaces while providing critical wraparound services for vulnerable families. In 2017-2018, United Way provided 961 children with free spaces in high quality early education programs, as well as providing essential teacher training and supportive services for local families. United Way has partnered with 14 early education centers, including the Clark County School District, to fund early childhood education classrooms during this 4-year grant with the goal of helping children learn to read, write and problem solve so they are ready for kindergarten.

United Way of Southern Nevada works to empower the community with committed programs dedicated to building up a base of local advocates for positive change.
